XCS Large Cargo Loss Advices 01/04/2009 to 31/03/2010

The Joint Cargo Committee has received the annual spreadsheet prepared by the XCS Cargo Department incorporating large losses (incurred Lloyd's share of US\$500,000 and above) advised over the twelve month period shown.

As per previous years, the following criteria apply:

- The list covers losses ADVISED to XCS Cargo Group during the twelve month period commencing 1st April 2008, it does not represent losses occurring during that period although a Date of Loss field has been incorporated which hopefully will be of some benefit to underwriters in identifying a Year of Account.
- 2. The list only captures losses of US\$ 500,000 and above.
- 3. The list does not include any risks written 100% by London companies but will include losses which involve both the Lloyd's and company market.
- 4. The figures only include losses advised to XCS. Consequently any losses that may have been written a 100% by a single syndicate OR has a leader only claims binding clause contained within the policy, thereby not necessitating a "PEER REVIEW" claims handling function, are not included as these would not have been processed by the XCS Cargo team in London.
- 5. Certain reinsurance business, for example treaty business, is not represented.
- 6. For some of the claims the figures shown are not yet "final" and may alter from those shown here.
- 7. Due to their confidential nature, the list excludes any payments associated with piracy and related GA settlements.
